In addition to the application form, please include the additional materials:

- Resume
- Unofficial transcripts (***must maintain a cumulative GPA of 3.0 or higher***)
- Letter of readiness - Please include a letter from someone who has directly supervised your work with clients. This letter should address progress in your program, your current level of skill, openness to supervision, and areas for growth. Anything else that may help us better know you can also be included.
- Class schedule of the semester for which you are applying
- Work schedule (if you have a part-time or full-time job for the semester for which you are applying)
- Current copy of professional liability insurance (such as American Professional, HPSO, etc.)
- Authorization to conduct a criminal background check (form)
- Authorization to conduct disciplinary/conduct/GPA verification through the Dean of Students Office (form)

DEADLINES

- The deadline for turning in your completed application packet for admission to the 2018 Fall semester is: Friday, May 11, 2018
- Interviews for the 2018 Fall semester will be conducted: the week of May 14 – 18, 2018
- Decisions about acceptance to 2018 Fall semester will be made by the week of: May 21-25, 2018 pending background check and disciplinary/conduct/GPA verification

The interview will include questions related to your application packet, previous experience and expectations of the practicum experience at the SHW Counseling Services.

We will also ask you to review a brief vignette and provide a case conceptualization and initial thoughts on treatment strategies. Our interest is in obtaining some understanding of your conceptualization skills and reasoning skills in approaching your work with clients. This is intended to help us assess your current skill level and will be helpful in making supervision assignments.
