Student Payments

Viewing your bill: Tuition and fee charges for Fall 2026 registration will begin posting to your account August 3, 2026.

Financial Aid: The earliest Financial Aid and Scholarships can begin disbursing federal, state, and institutional aid is 10 days prior to the first day of class.

Payment Deadlines & Late Fee: A \$35 late payment fee will be charged for students who have not made payment arrangements by 5 p.m. on the date of the relevant payment deadline (excluding the final deadline for the full 16-week term).

Removal from Classes: Students who are still unpaid by the scheduled payment deadline(s) will be removed from their classes.
