Attending OISSS CPT and OPT Workshops just got easier!



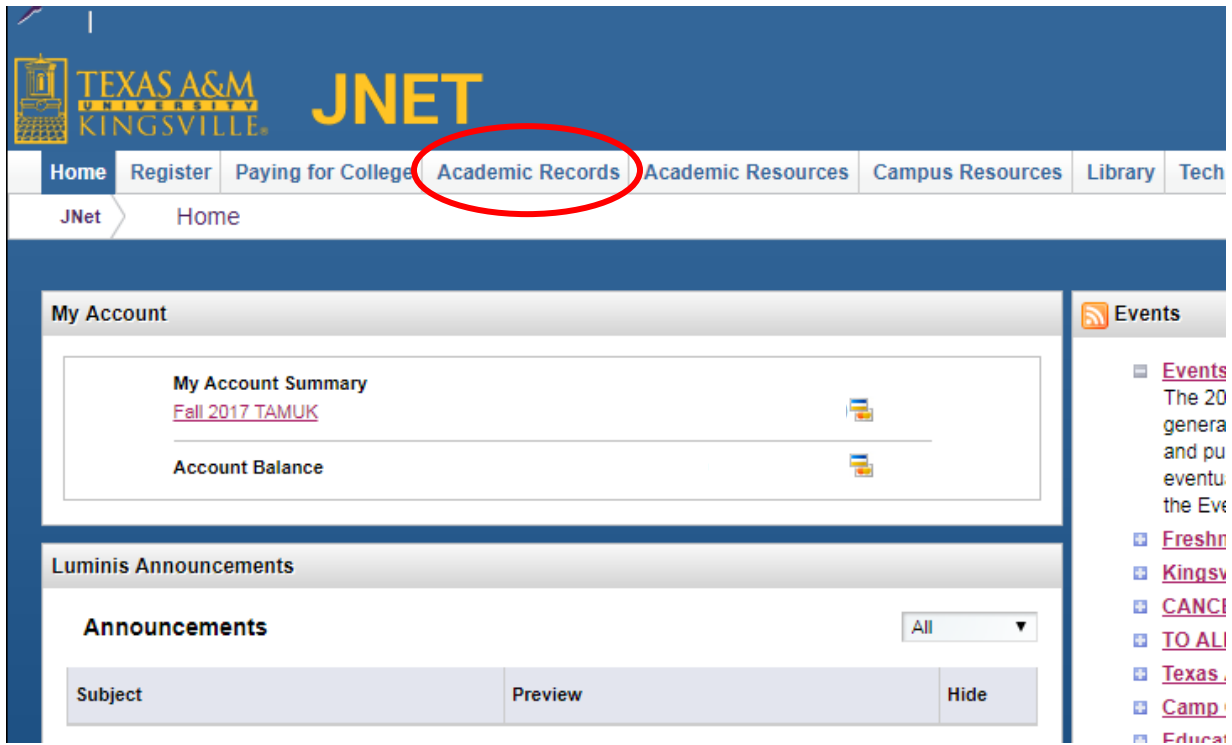

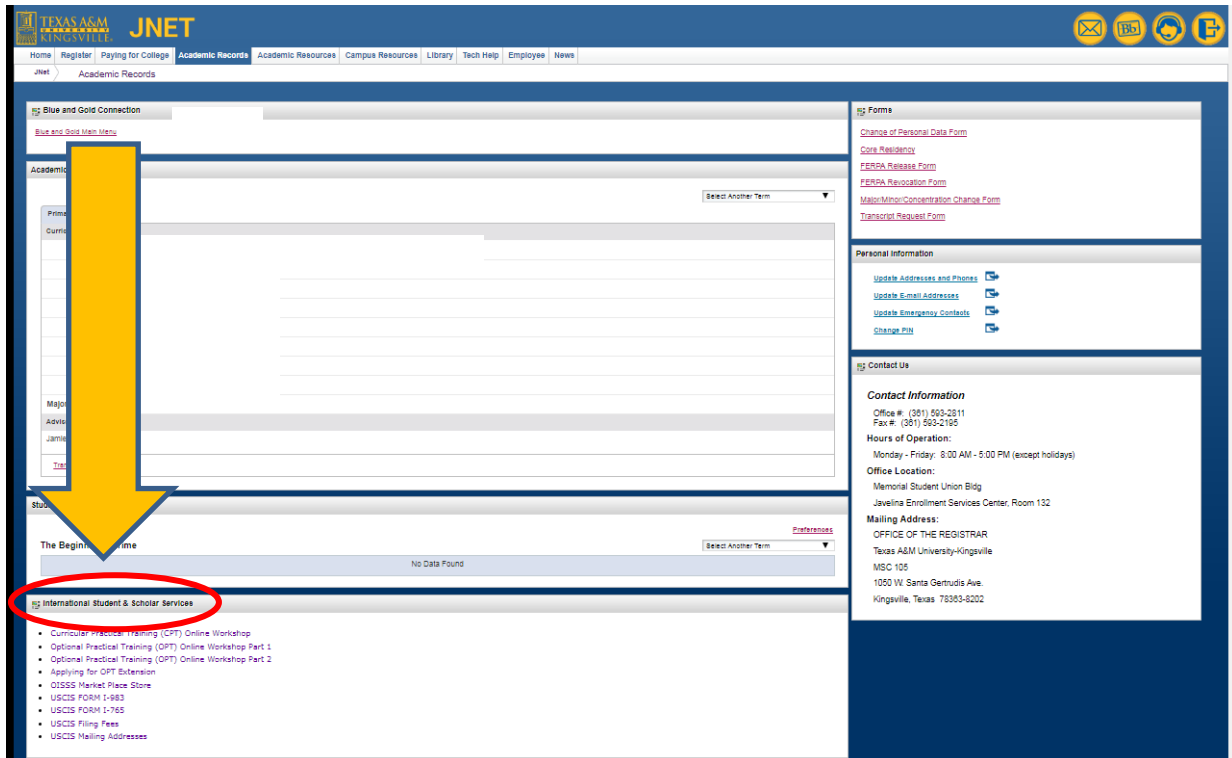

- Sep 9 F17-Three-peat charges are added



The OPT Online Workshop is broken up into three (3) parts. Students interested in applying for Post-Completion OPT Employment are required to view all three (3) videos prior to submitting their OISSS-150, Request for Post-Completion OPT Applications to OISSS for processing.

Validate

Once students check the box and click the “Validate” button, the OISSS will receive a notification verifying that the video has been viewed by the student. A DSO will check for these validations when processing student requests for Post-Completion OPT Employment.

Students may view and re-view these videos as often as they would like and are encouraged to do so, even after validation.
