Application for Mexican Student Tuition Reduction Waiver
Solicitud Para El Programa De Asistencia Estudiantil (PASE)

The **Programa de Asistencia Estudiantil**, known as the “**PASE**”, provides Mexican students, who are eligible, the opportunity to pay in-state tuition as if a resident of the State of Texas. Applicants must show documentation to prove personal or family financial need as demonstrated by a brief socio-economic report. The duration of the PASE is for one academic year beginning in the Fall Semester and it covers the Spring Semester and both Summer Terms. There is no cost to submit this application.

Requirements Dictated by the State of Texas

1. Must be a citizen of Mexico or permanent resident of Mexico.
2. Must demonstrate financial need.
3. Maintain a minimum academic cumulative GPA of 2.0 or better (undergraduates) and a minimum cumulative GPA of 3.0 or better (graduates and doctoral) per semester.
