- 6. Agriculture, Environment & Society; this course explores current agricultural economic policies. While delving into the historical contribution agriculture has made to society through the ages. The classroom is set-up as a round-table discussion with students researching and presenting ideas to solve various environmental and social issues impacting today's culture.

7. Agriculture Communications; course teaches contemporary communication methods related to the agricultural industry. Students learn how to write press releases, white papers and policy statements for agricultural companies. In addition, students practice public speaking in front of a camera, media interviews and being a company spokesperson.
