Message from the Dean

This past academic year has been extraordinary for us all. I am immensely grateful for the team of faculty, staff, students, alumni and friends of the College of Business Administration for their dedication in pushing forward through the many different obstacles placed in our path. We remain focused on our mission in providing an accessible, high quality, comprehensive business education and empowering our students.

Class modality was shifted to 100% online this past academic year, but that did not impact the engagement between faculty and their students. Students worked on virtual projects with different business entities, participated in simulated challenges led by national student organizations and obtained designated program specific certifications. Our students also offered free tax preparation with the VITA program again this year through virtual appointments or curbside drop-offs.

Faculty research productivity continued and new opportunities for collaboration were presented and taken full advantage of by our college. Several of our faculty were recognized for their scholarly and intellectual contributions this past year. They participated in nearly 100 recruitment events, both virtual and in-person visiting with prospective students and their families. U.S. News and World Report ranked our MBA degree among the top 100 in the nation. We are working on expanding our portfolio of programs to include a Master in Taxation that will begin to be offered in fall 2022.

Despite these trying times our alumni and friends have continued to share their expertise and support through scholarships, increasing internship opportunities and expanding career networks for business students.

In this issue of the Business Journal, we feature our movement forward together as a team, showing our strength and commitment to assuring that our students will be equipped with the necessary tools to handle any obstacles in their pathway towards success.

from the Pandemic Co H H H DR. GIJS VAN OORT RESEARCH

In mid 2020, at the height of the COVID-19 epidemic, the LBJ School of Public Affairs published a report outlining nine critical components for recovery and creating a resilient Texas.¹ Of those, several could be facilitated by academic institutions;

- Building partnerships instead of rivalries
- Leveraging Texas universities as community hubs and accelerators for talent and thought leadership.
- Promoting the growth of rural
- communities with state-supported
- investments.

The Dean of the College of Business Administration encouraged the formation of a multi-departmental steering committee to address these three components and determine ways in which Texas A&M University-Kingsville could act on them. The vision was to include multiple departments and community organization in order to optimize the efforts for pandemic assessment and pandemic recovery. Given that rural America is disadvantaged in healthcare access and has less diverse economic drivers, therefore being proportionally more impacted by the pandemic, the focus of the overall project was on rural and semi-urban regions, the primary market for Texas A&M-Kingsville.

The steering committee was formed in late October 2020 and created an umbrella concept around pandemic assessment and pandemic recovery. Participating faculty

developed specific projects under this umbrella in line with their expertise and interests (see: Fig. 1). Currently the College of Business Administration, College of Education and Human Performance, and Irma Lerma Rangel College of Pharmacy are represented in the project.

Several meetings with community organizations were held, including food banks, economic development board, EMS services and health care representatives. The most traction the project has obtained to date is the work done with regional food banks, addressing the social changes that people experienced during the pandemic.

The survey followed the Social Determinants of Health guidelines, as utilized by CMS in assessing health status. Baseline data of over 1000 food bank users in South Texas and Northern New Mexico were collected and analyzed. The survey will be repeated every quarter in 2021, in order to assess changing social demands during the anticipated recovery. The collaboration with the respective foodbanks has been a win-win, since foodbanks need this type of information as part of their strategic positioning in their service area.


A second initiative around the effect of teaching children remotely on teachers and counselors in elementary and middle schools has been created and validated with front-line practitioners. This will mostly be a retrospective view as many schools in Texas are back in the classroom. While awaiting IRB approval, the study is ready to be put in the field.

Knowing the effect of the pandemic on the regional economy, part-time and seasonal workers have been heavily impacted. A study is in development to determine attitudes to -and impact of- job lay-offs of these part-time workers. This study intends to combine survey tools and interviews to assess workers' attitudes towards these part-time employments.

Mental health changes have worsened during the pandemic, in part due to financial pressures, social isolation and other stress factors. Pharmacy faculty is working with a pharmacy chain to determine changes in anxiety and depression prescriptions during the 2020 year in comparison the previous year. The study will be based on deidentified data streams for the pharmacy and depending on community participation- be linked to medical data for mental health. Needless-to-say, IRB

In summary, the focus on pandemic recovery as an overall theme is well timed and addresses many social aspects of a community. While still early in its implementation, results so far have been revealing and serve as a basis for continued exploration and reporting.






approval will be critical. The pandemic impact on transportation is another critical factor that affects the social fiber of a community and a family. With public transport services decreased (due to social restrictions) people are less likely to travel and if they needed to travel transportation dependency was difficult and cumbersome. While this issue is addressed in the food bank survey. responses may be biased since participating respondents need transportation to make it the food

COLLEGE OF BUSINESS ADMINISTRATION GOES VIRTUAL



Students meet via Zoom every Monday to learn about topics such as the different Covid-19 protocols and situation, Renewable energy, and differing regulatory and legal issues around the world. Each week's seminar is hosted by Luephana professor Dr. Schomerus with guest speakers from the US, India, Iraq, Saudi Arabia, the United Nations and Taiwan.

In addition to our students. several College of Business Administration faculty including Professors Schumann, Procasky, Singh and Fernandez have been available to comment on the topic from the US's perspective.

It is hoped that next summer, we will again be able to restart our in-person study abroad program bringing our students to Lüneburg Germany and extending invitations to Leuphana students to visit Texas.

Business Administration (CBA) at Texas A&M University-Kingsville hosted its annual Economic Forum. but this year it was virtual. The 10th annual Economic Forum was held for an hour online on Tuesday, Nov. 3, 2020.

This year's keynote speaker was Texas Comptroller Glenn Hegar. He talked about Navigating the Road to Recovery: An Overview of the Fiscal Health of the State and Challenges for Texas in the Upcoming 87th Legislative Session.

This year's forum featured a study of three South Texas counties that have similar COVID-19 case levels. Dr. Thomas Krueger, J.R. Manning Endowed Professor of Innovation in Business Education and chair of the department of accounting and finance from the College of Business Administration, presented his research entitled Economic Conditions in Kleberg County, Fayette County, and Medina County: Three South Texas Counties with Similar COVID-19 Case Levels.

Taxation in **Demand** NEW ONLINE MASTER'S PROGRAM

The Texas Workforce Commission projects the state of Texas will see an increase in tax preparers of over 20 percent through 2026. The occupation of accountants and auditors is expected to increase nearly 19 percent in the same time period

To that end, administrators in the College of Business Administration at Texas A&M University-Kingsville will begin a new program in the fall 2021 semester geared toward filling the gap. The Texas Higher Education Coordinating Board recently approved a new online master's degree program in taxation.

The new program will enable students to obtain a Master's of Science degree in Taxation (MST) in one year and meet the educational requirements for the Certified Public Accountants (CPA) examination.

"The newly approved Master of Science in Taxation degree focuses on the theoretical and technical aspects of taxes and tax law. As long as governments continue to operate, individuals and businesses need professional assistance of tax experts," said Dr. Natalya Delcoure, dean of the College of Business Administration.

"According to the Bureau of Labor Statistics, the need for tax professionals is expected to grow over 10 percent in the next 10 years, a rate faster than the national average that will result in over 139,000 news jobs by 2030. The Master of Science in Taxation will help accounting

students to broaden then knowledge, prepare them to sit for the CPA exam and improve their career opportunities," she added.

The new degree will be housed in the accounting and finance department under chair Dr. Thomas Krueger, Professor of Innovation in Business Education. The degree consists of 30 semester credit hours in advanced classes in taxation, graduate economics and finance classes and a strategic management capstone course.

"The integration of taxation courses and business courses equips students with a comprehensive yet specialized understanding of how the complexities of tax laws impact individuals and businesses. Through practical and technical coursework, students will gain the knowledge and skills needed to succeed as a tax professional or business manager," Krueger said.

"The study of taxation is a good way for students to learn how to effectively manage budgets and money. Career opportunities are possible with Big Four Accounting firms, including Ernst & Young, which has recruited on our campus, consultancy firms, government institutions and financial institutions," he added

"Students will sharpen their skills as a tax professional while staving current with industry and economic trends. Through training as tax experts, students will acquire skills that are relevant in almost any domain," Krueger said.

"Tax skills are critical whether one is hoping to become a certified public accountant, corporate executive, or financial planning consultant. Continued revision of the tax laws is likely to result in high demand, career progression and interesting, varying assignments for our MST graduates."

Student recruitment for the new degree will be associated with the recruitment program currently used for the existing online MBA program. MST applicants will be sought at the same graduate and career fairs visited by the MBA recruiters. Marketing of the MST will use similar materials and strategy as the successful MBA.

Classes for the MST will be taught by existing faculty and no additional equipment of facilities will be needed.

Currently, no public institution in the region offers an online Master of Science in Taxation degree program. University of Texas Rio Grande Valley and Texas A&M University-Commerce offer a tax credential in a fully online program, but it is a concentration within a Master of Accountancy degree.
