# MESSAGE FROM THE TITLE IX COORDINATOR

As some of our students may be aware, there have been some changes within the Texas Education Code and federal guidance from the Department of Education. To comply with the new requirements in the Texas Education Code, TAMUK has provided an anonymous reporting option on the TAMUK home page and began requiring online training on sexual misconduct for all incoming freshmen and undergraduate transfer students. Furthermore, Texas A&M System Regulation *o8.01.01*, *Civil Rights Compliance* is currently compliant with the new interim guidance issued by the Department of Education.

Fall 2017 was a great semester. There were many opportunities for faculty, staff and students to learn about resources and the university's sexual misconduct policies. It was exciting meeting students at informational booths at Javelina Health Fest, Oksoberfest, and the Dating and Domestic Violence Awareness Month pledge wall.

In October, The Office of Compliance worked with The Women's Shelter of South Texas to hold an informational lunch on off-campus resources available for students experiencing relationship violence. Additionally, the Office of Compliance partnered with the University Police Department to offer female faculty, staff, and students a free self-defense class.

Throughout the semester, multiple trainings were conducted that focused on consent, how to report sexual misconduct, and campus policies. During some of these trainings, the Office of Compliance partnered with PEP Talk representatives to offer Bystander Intervention Training.

As we begin the spring semester, I look forward to continuing these educational opportunities. ### **EVERFI TRAINING**

Texas A&M University-Kingsville has partnered with EverFi to offer online training for students, faculty, and staff. Currently, students are able to take Haven: Understanding Sexual Assault and AlcoholEdu: for College through the Campus Resources tab on JNet. Faculty and staff are able to take Haven for Faculty & Staff.

There has been an increase in student participation from last year. Students increased the completion rate of Haven by over 2000% and AlcoholEdu by over 1000%.

Due to new legislative requirements, TAMUK has also started to require the offered trainings for certain groups of students.

**First year students:** Students enrolled in UNIV will be required to take Haven and AlcoholEdu for a grade. Additionally, starting next year, first year students must complete Haven with a passing score prior to early registration or have a hold placed on their account.

#### **Undergraduate first-semester transfer students:**

This semester, undergraduate first-semester transfer students are required to complete Haven with a passing score prior to early registration. Failure to complete Haven will result in a hold on their account preventing them from registering until Haven is complete. In addition, undergraduate first-semester transfer students are encouraged to register and complete AlcoholEdu.

**All other students:** All other students are encourage to register and complete the AlcoholEdu and Haven trainings.

If you or someone you know has experienced sexual harassment, sexual assault, dating violence, domestic violence, or stalking, there are resources available to you.

You may also make an appointment with a Licensed Professional Counselor (LPC) at Student Health and Wellness. LPCs are university employees who are not required to disclose sexual misconduct to the Title IX Coordinator.

## TAMUK POLICY AND PROCEDURE STATEMENT

Texas A&M University-Kingsville is committed to ensuring a campus community that is safe for all students and employees. Under Texas A&M System Regulation *o8.01.01*, *Civil Rights Compliance* (*policies.tamus.edu/o8-01-01.pdf*), all Texas A&M University-Kingsville employees are responsible for reporting alleged or suspected incidents of sex discrimination, harassment, assault, misconduct, or violence. Student employees, including but not limited to resident advisors, are considered university employees for purposes of this regulation. Employees are required to inform the Title IX Coordinator of all relevant information, including names, even if the individual who made the disclosure requests privacy. Requests for privacy will be evaluated, by the Office of Compliance, in the context of the university's responsibility to provide a safe and nondiscriminatory environment.
