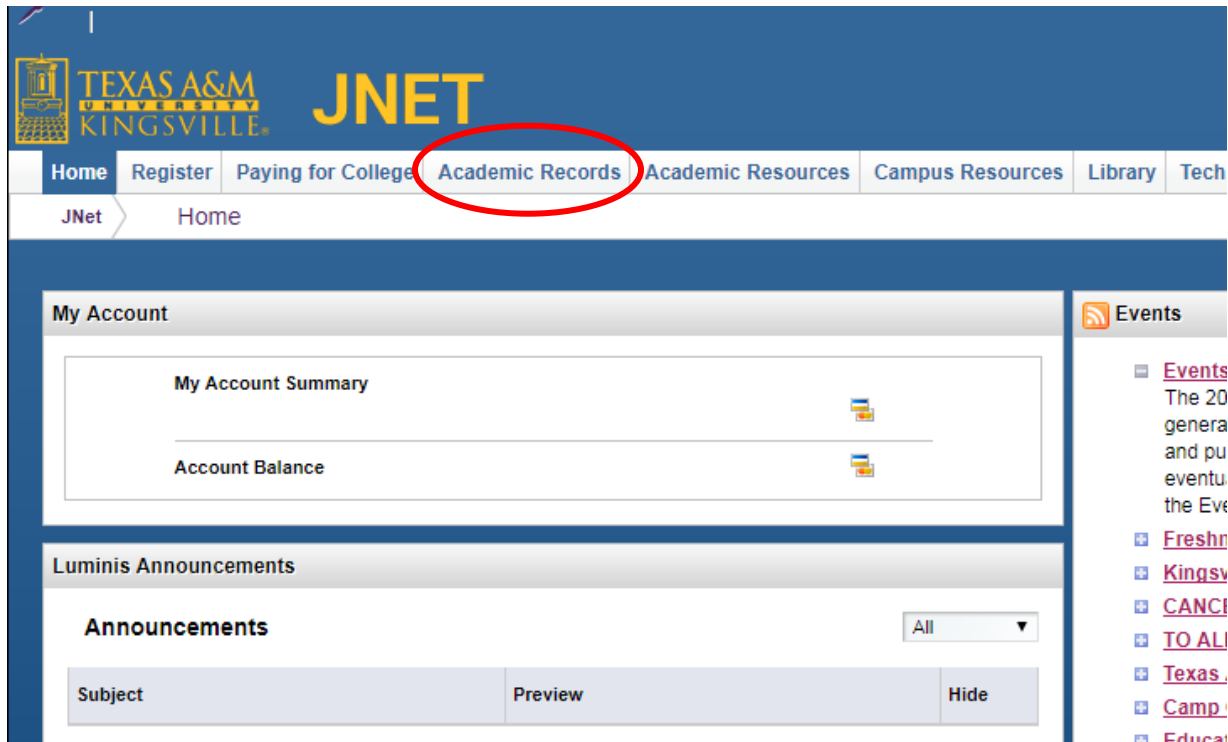

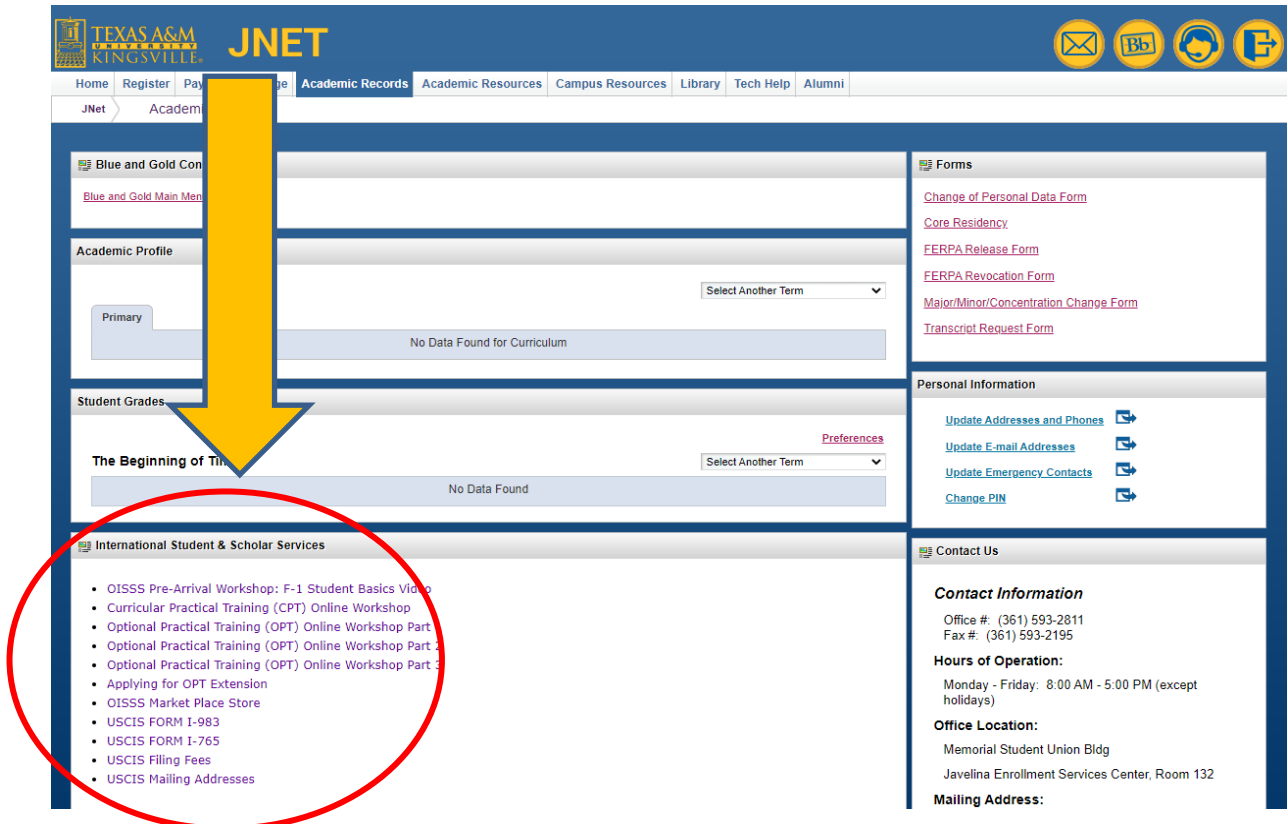



The F-1/J-1 Regulation Basics Workshop consists of (1) 13-minute video and can viewed and re-viewed at any time.
