- I. Call to order 3:31
  - a. Quorum call Quorum Present
- II. Approval of minutes, February Meeting. Motion: Senator Thomas. Second: Senator Thomas. Approved by voice vote.
- III. Presentations
  - a. PROVOST Rex Gandy
    - i. With the SACS ten-year reaffirmation procedure, this has been a busy year, and the President, Provost, and the leadership team appreciate the Faculty Senate's effort under the leadership of President Challoo. This has certainly been the most active Senate year since my arrival to TAMUK.
    - ii. THECB has returned our proposed undergraduate core with some changes, particularly in Creative Arts and the Component Option area. The new core was largely approved, so it should stand for the next ten years, needed tweaks notwithstanding.
    - iii. Enrollment is up 12% and SCHs are up 8%. Spring 2014 enrollment may set a record for spring enrollments at this institution.
  - b. ASSISTANT VICE PRESIDENT Duane Gardiner
    - Continuation Procedures and Tenure section proposed for the Faculty Handbook: Senator Williams moved that the proposed changes be accepted; Senator Verma seconded. The motion passed by voice vote.
    - ii. Senate Standing Committees and University Committees: Pages of the handbook of committees with changes were distributed.
      - Following discussion, Senator Schumann suggested a revised version of option 2 on page 20 to read "one additional faculty member for each academic college appointed by the President of the Faculty Senate after consultation with the appropriate Dean." Senator Williams moved that the revised option 2 on page 20 be adopted; Senator Verma seconded. The motion passed by voice vote with one abstaining and one opposed.

- Regarding options on page 30, Senator Williams moved to adopt option 1 and Senator Schumann seconded the motion. The motion passed by voice vote

Senator Vargas moved to include the Concept Paper in the Faculty Handbook section on Post-Tenure Review. Senator Goswami seconded the motion. The motion passed by voice vote.
